RULESGENERAL

1. Membership is restricted to families living in Country Club Hills. Exception at the discretion of the club.
2. The club is limited to 20 members.
3. Names of prospective members are to be brought up at business meeting and unanimously approved by members present. Those approved must be contacted by the Secretary and given a copy of these rules prior to using the club. If new members are to be discussed at the coming meeting, or new business taken up, inform secretary by 20th of the month so members can be informed while she's calling.
4. A new member is not allowed to propose a prospective member unless she has been in the club three months.
5. Husband will pick up and escort sitter home for evening sit on request.

MONTHLY MEETINGS

1. Monthly meetings are held on the first Thursday night of each month starting at 8:30. Hostess may set another night if that night is not agreeable with her. The first thing on the agenda must be a short business meeting conducted in a formal manner by the SECRETARY and promptly at 9:00 for those only able to stay a short time.
2. Turns for secretary will be taken alphabetically. Exception: new members must be in the club three months before taking turn as Secretary or Hostess.
3. Turns for hostess will be on an alphabetically rotating basis separately from secretary.

HOURS

1. Time starts counting from the time you ask the sitter to come.
2. The sitter is to look at the time the minute the parents come home. Count the time and decide upon it immediately.
3. The one who does the sitting calls the time into the secretary the next day.
4. Hour Tabulation - $\frac{1}{2}$ Hour Basis:

7 a.m. - 5 p.m.	1 hr. per one child, each additional child $\frac{1}{2}$ hr.
5 p.m. - 7 p.m.	Double time
7 p.m. - 1 a.m.	Single time
1 a.m. - 7 a.m.	Double time

Less than 15 minutes is disregarded. (Double actual minutes of your double time.) Minimum credit is two hours.

5. Double time given when sitting with club member and a house guest. (No double-double time.)
6. Members with more than 20 hours minus must sit before using the club again.

POINTS OF COOPERATION

1. In case of sickness in family of sitter, secretary will replace sitter if possible. If no sitter is available person needing sitter is responsible for own sitter.
2. If sitter receives last minute invitation she calls secretary to find replacement. If no sitter replacement is available from our club she is responsible to sit herself.
3. If you wish to cancel because you are not going out, call both the sitter and the secretary as soon as you definitely know.
4. Secretary will notify member as soon as possible if she's unable to get a sitter. Member may check with secretary if she hasn't heard that a sit will be filled.
5. Courtesies: Snack for sitter, pillow and blanket.

RULES

1. A family is eligible to belong to the Co-op Sitters' group if the youngest child is at least six months old and is off the ten o'clock bottle.
2. A prospective member must be unanimously approved by the group before being approached.
3. The time starts counting at the time you ask the sitter to come.
4. The sitter is to look at the time the minute the parents come into the apartment. Count the time, and decide upon it immediately.
5. Time between 7:30 and 12:00 is counted as straight time on a $\frac{1}{2}$ hour basis.
 - a. Less than 15 minutes is disregarded.
6. Double time is counted before 7:30 and after 12:00 o'clock.
 - a. Total actual minutes of your double time, multiply by 2, to arrive at the total double count. Disregard less than 15 minutes.
7. When a sitter reports, one hour is the minimum time credited to her.
8. The one who does the sitting calls the time into the secretary the next morning.
9. The husband walks the sitter home.
10. Each member takes a turn at being secretary for a period of one month. The one who follows the acting secretary is her alternate. A new member will be expected to take her turn as secretary after she has been a member for six months.
11. Members will not be asked to sit for children of friends or relatives of Group-Sitters, with the exception stated in #12.
12. If a person has a legitimate house guest and the children are within age limit, a sitter may be obtained from our group on a double time basis only. i.e. On a double-double time basis before 7:30 and after 12.
13. Monthly meetings are to be held the last _____ night of each month.
14. The secretary must hold a formal business meeting at the beginning of the evening. New members names are to be submitted at this time.

Points of Co-operation

1. In case of adult sickness in family of sitter, secretary will replace sitter if possible. If no sitter is available person needing sitter is responsible for own sitter.
2. If sitter receives last minute invitation she calls secretary to find replacement. If no replacement is available from our club she is responsible to sit herself.
3. If you wish to cancel because you are not going out call both sitter and secretary as soon as you definitely know.
4. If you use a sitter early (before 7PM or so) or on Saturday nights be prepared to sit in return likewise.
5. Membership will be contingent on three members sponsorship, before being presented for unanimous group approval.
