BUSINESS MEETING AND REPORT TO THE CCHCA MEMBERSHIP

Report from the Board and Committees

President – Stephen Lescure

- Thanked everyone for making the time for the online meeting.
- Commented about the Country Club Commons Connector Trail Project Meeting. The City described the project. A lot of neighbors participated and a lot of people had and will submit the survey about the project.
 - The City has approved to request funding for the trail.
 - Potential development would take over the next 6 or 7 years.
- There are some homeless people living in the neighborhood. The City is in the process to resolve the situation.
- There is a person making up a video about the "beauty spot" section for CCHCA website.
- We are thankful there is a new volunteer, Rose.

Treasurer - Toby Sorensen

- Current Balance \$10,235.92 (See July 16th Treasurer's spreadsheet)

- City Council approved the Northfax project with a 6-0 vote on July 14th, 2020.
- Other developments in the City are being discussed each week.
- In Phase 3, the Museum and Visitor's Center and Blenheim Civil War Center are open with safety precautions.
- The destruction of several signs and statues in the City is being addressed by Historic Fairfax
- City Inc. in the form of a memo to the City Manager.
