## Old Business

At the April 21<sup>st</sup> Board meeting several members of the Standing Committees brought up the fact the the Standing Committee Chairs were not included in participating in voting. A motion was made by Carney and seconded by Sorensen. After discussion a vote was taken and the motion to approve Committee Chairs to be able to vote was unanimously approved. By-laws Chair Steve Lane was asked to include the change in the by-laws.

In the absence of Steve Lane, Carney presented the new change in ARTICLE VI. In Section 1, the change in the last sentence has changed to "six" Board members shall constitute a quorum. Section 3 was added to accommodate the vote:

### **"ARTICLE VI**

#### **MEETINGS OF THE BOARD.**

**Section 1.** Regular meetings of the Board shall be held at least once per quarter on a date designated by the Board. Special meetings may be called by the President or upon the request of any three members. A minimum of six Board members shall constitute a quorum.

**Section 2.** A special meeting of the Board shall also be called upon the written request of any 15 members of the Corporation. At such meeting, duly designated representatives of said members may attend to present any problem and proposed solutions for consideration by the Board.

**Section 3.** When the Board votes on action items at meetings, committee chairs shall also be entitled to vote."

The change was proposed to the membership and it was unanimously approve. A corrected copy of the by-laws was available to the membership and it will be listed on the website.

Carney introduced Katy Johnson, Nominating Chair and thanked her for her work in filling the slots for the upcoming year:

Johnson introduced the 2022 Directors and Committee Chairs. (List attached) She asked if there were any nominations, questions or discussion from the membership. Are there any objections? If not, please signify "aye" for approval of 2022 Board.

Carney introduced a special CCH member who will be the leader of the swearing in Ceremony. Nancy J Jones and her husband Al moved into their home on Spring Lake Terrace over 40 years ago. They raised their 2 boys here. " Nancy has been active in the Civic Association and held positions over the years.
