Bill Craig reports that Block Watch is running smoothly. With over 70 volunteers who. patrol our neighborhood every Fri. and Sat. night between 9 p.m. and 1 a.m., we can literally "rest assured."



CIVIC NEWS BRIEFS

On May 22, 1984, our CCHCA President, Nolm-Desmarais, made a public presentation to the City Council. His presentation covered four key points: (1) Our rejuvenated Association intends to become more active in civic affairs. Norm mentioned that 621 CCH residents are registered voters who cast almost 8% of the City wide totals in the November '83 election. (2) CCHCA thanked the City Manager, Ed Wyatt: Assistant Mgr., Jon Ellestad: Police Chief, Lloyd Smith: Police Information Officer, Tom Welle: Officers Peacher and Barrington for helping CCH in strengthening the Association and for training our Neighborhood Block Watch Committee. (3) CCHCA recommended that the Old Fairfax Elementary School on Main Street, which had been used as a Police Academy, be sold for appropriate commercial development. Norm also recommended that the softball field and playground be retained for local residents and FPYC use. The original historic elementary school(now boarded up) should be retained and renovated by private donations, if possible. Proceeds from the sale of the main building should be used for needed capital improvements to the John C. Wood Community Center or allocated to other projects noted in the current Five Year Capital Improvement Program. (4) CCHCA joined the entire City in honoring Mr. Lee Wigren after his many years of devoted, conscientious service to the City. ****

Fairfax County has announced that it will move the County Police Helicopter Unit base from the Massey Building in Fairfax City to the former County landfill site further west of I-66. While your Mayor and Council were instrumental in securing this relief to the City, your Civic Association is proud to report that its multiple efforts in uniting other Associations in opposition to this plan were also instrumental factors in changing the heliport site plan.

PUBLIC WORKS DEPT. VISITS CCH Mr. Shull, the City Engineer, recently toured portions of CCH with Board Member, Larry Larsen. Mr. Shull discussed several points of interest to CCH: (1) the removal of the crab apple tree stumps will definitely be made this year but may not be completed by the summer as planned. (2) The repair of damaged storm drains and curbs will continue throughout CCH. More on this in forthcoming issues of Echoes. (3) The small creek running from Old Lee Hwy NW between Farifax High School and CCH should not be dredged out as some residents have suggested. Mr. Shull said that the natural leaf and brush build-up prevents serious erosion. The bigger problem is apparently caused by the residents whose backyards border the creek. They have been building large piles of brush, logs, and leaves, causing damage to the natural drainage of the area. This writer is one of the quilty culprits...I've always thought that the biodegradable leaves and brush would present no problem -- but it does. In addition to brush and leaves, Larry and Mr. Shull noted other refuse like pipes, old swing sets, etc., which contribute to the drainage problem and create breeding places for mice, snakes, and mosquitoes. Mr. Shull suggests that the residents place all refuse and leaves in the street for City pick up.

***** THE BAYOU REVISITED?

The small swamp and stagnant pool next to the unsightly footbridge leading up to F.H.S., will be repaired by the City or by the County: the County is responsible for the maintenance of the school grounds. The second small swamp behind the Spring Lake Terrace homes will also be drained as time and priority permit.

******NEW BIKEWAYS AND WALKWAYS FOR CCH-DO YOU WANT THEM?

The further improvement and development of bikeways and walkways throughout the City is one area of interest to your Executive Board. Existing (and funded) plans call for 1984-1985 completion of a trail running along Spring Lake Terrace to the foot of Brookwood Drand from there across the "green space" to (and across) the small creek via a wooden footbridge, through the woods, to where the trail will eventually cross under Route 50 in an attempt to connect with the Mosby Woods and Fairfax County trails going east, west, and north. All CCH sections have been completed, except for the sections of the wooden footbridge. Mr. Shull said that even though funds for the project had been appropriated last year, the project was placed on temporary hold due to the complaints received from one resident in CCH. Your Executive Board has recommended approval of the project and construction of the footbridge. This project will provide additional safe walkways and bikeways for CCH recreation purposes, and it will offer a safe route for CCH walkers to either the 7-ll store in Mosby Woods' area or to Victoria Station. In addition, it will offer CCH commuters an alternate route in order to catch the City Express or Metro Buses that run along Route 50. Your Association intends to request continuation of this project unless we hear your views to the contrary. If you do NOT want this project to continue, please make sure to call Larry or Norm by July 3rd.

The BLOCK MOTHERS PROGRAM is one of the most well supported and valuable programs in our City. Developed in coordination with the Police Department, area schools, and residents, this program ensures emergency aid and assistance to our school age children during the time they walk to and from school. Volunteer Block Mothers place a bright orange sign in a front window of their home; this sign signifies their position as a Block Mother and is immediately recognized by the children who have been made aware of the program's purpose and mission. Volunteer Block Mothers have been called upon to provide everything from a "Band-Aid" to temporary shelter from the cold when a house key has been inadvertently tossed into the cafeteria garbage pail at lunch time. In addition to the comfort they provide a lost or distressed child, Block Mothers observe their areas and, during the a.m. and p.m. "school walk" hours, watch for any signs of trouble or suspicious behavior. If you care to join the program or if you need a new sign, please call Betty Keshka, our area Chairperson, at 385-8370.

Betty acts as area liaison between our residents and the Police Information Officer, Tom Welle. Recently, Betty informed the Block Mothers of the suspicious behavior of a suspected child molester who was seen at Providence Park and later spotted at the Jermantown School area. Betty suggests that you notify the Police Department if you see anyone

fitting the following description:

"Caucasian male, 145 lbs, 5'll, approx. 36 years old. Full dark beard and bushy, dark collar length hair: wire-rimmed glasses. Driving a 4 door, 1983 blue Datsun, Virginia plates BCC-CBL. Suspect was NOT sporting beard when seen in the Jermantown area."

Betty will keep us informed of the Block Mother activities, and she will provide us with any information concerning incidents that affect us.


