### SOME EXAMPLES OF WHEN ONE VOTE MADE A DIFFERENCE

Connecticut --In 1962, a State Representative to the General Assembly was elected in Newington by one vote -- winner...4,164; loser...4,163.

Idaho --In a recent Primary Election, an incumbent United States Senator was defeated by less than one-quarter vote per precinct. With 889 precincts voting in 44 counties, the winner's margin was 200 votes.

Classic Example --Marcus Morton was elected Governor of Massachusetts in 1839 by one vote out of 102,066 cast.

## CRIMINAL CODE

## Sec. 11 Parking in Residential Areal

From and after the effective date of this section, no person shall, in any area of the City of Fairfax zoned for residential use, park on a street or on a driveway in such area any trucks or buses or other commercial vehicles exceeding 8,000 pounds gross weight licensed capacity; provided, however, that one commercial vehicle only, regardless of weight, may be parked within a garage on any given premises in such residential area, and provided further that the foregoing probation shall not be deemed to prohibit the temporary stopping of commercial vehicles on such streets or driveways for the purposes of loading or unloading, or for necessary repairs.

## DOG NEWS

This situation keeps coming up over and over again. The latest was from a mother whose child was frantic and frightened one morning on the way to school. The whole situation is bad enough since the only kids walking to school here in CCH are 1st and 2nd graders -- without benefit of older brother, sister or friend protection!!



## DOG NEWS (Cont'd)

So, there was the child back home, too late to send on his way again because the crossing guard was gone, and two small ones to care for and no car... The mother called us and asked us to mention in our next bulletin that it would be appreciated if people kept their dogs in in the morning while children were on their way to school! Why should she have to make such a request??? What makes your animal more important than her child??? Indeed the animal is breaking the law--not the child!! Way back after our March 14 bulletin we received a letter from a resident dated March 16th and we quote:

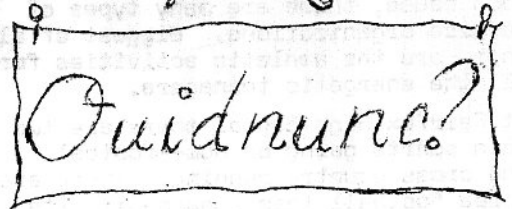
"Regarding the dog situation. I checked personally with the office of the City Attorney. We have an ordinance that makes it unlawful for owners to let dogs run at large. Therefore, we should call the Police and insist upon it being enforced. This has been my mode of attack, and it has produced results. The Police usually ask me to make a complaint, and I tell them 'Why do I have to complain specifically about your not enforcing an existing ordinance? I am a pet lover also, and am reluctant to call, just like everyone else is, but the problem is so obvious that the Police should not require complaints.'

If we could get more people to make a personal call to the Chief of Police himself and kindly ask that he enforce existing ordinances, on dogs running at large, I believe it would do a lot of good. I am going to call him today and do so, as I have done before."...

We have also received complaints of long and sustained barking dogs and yowling cats. There are towns whose ordinances include this aspect unlawful as a "nuisance". Citizen request to the City Council might accomplish this. With reference to cats the animal warden does advise us that a warrant can be issued for trespassing on your land.

CHAMBER OF COMMERCE:

Tells us that: Virginia Trailways is now operating through the Fairfax City Bus Terminal (50-29-211 at 123). There are 15 trips a day from Fairfax to Washington and 17 return trips. Trailways gives the travel time at 48 minutes. In addition, there are about 16 interstate trips to points North, South and West from the Terminal daily. Agent at the site is Vincent's Octagon.

...WV&M Service...Local in-city service is not doing well. The average is less than five passengers per trip. If the service does not hold its own, it will be dropped in December. Your help in keeping this service is needed.

(P.S. We have talked to the bus company executives on this matter. A number of CCH'ers called and said that a bus service which does not make a loop through CCH and whose service time ends shortly after 3P.M. is of no use to the bedraggled mother chauffeur or the one-car family. We think that complaints to the store owners and the Chamber from a lot of individuals would help this situation. It really is a tough one for all concerned. Our Civic Assoc. is on record supporting the start of this bus system. We sincerely hope that it can be continued!)

On Thursday, October 22 at 8:15 p.m., Dr. Herring, Dean of George Mason College, and representative of leading civic and service groups was the special guest at the home of Norma Peterson, 594 Springlake Terrace. The purpose of the meeting, initiated by Jenne Jones, chairman of the League's City Planning and Zoning Committee was to effect "an exchange of ideas between town and gown" regarding the relationship of the college to the physical, cultural and recreational development of the City.

League members and prospective members concerned about the improvement of election laws to facilitate and increase registration and voting, and in fair representation based primarily on population are urged to attend one of two area meetings on Wednesday evening, October 28 at 7:45, and Thursday, October 29 at 9:45 a.m. at the John Calvin Presbyterian Church, Columbia Pike. Further League stands will be taken on reapportionment.

The League asks all citizens to write to Gov. Harrison urging him to call a special session of the Legislature for reapportionment by December 15.

"THE MALE ANIMAL"

The Fairfax Community Theatre is going to treat the area's theatre goers to a presentation of "The Male Animal" by James Thurber and Elliott Nugent. It will be given on Nov. 6, 7, 13 and 14th. Tickets may be obtained locally by calling Marilyn Hedges, Gr 3-1587. The play, which is set on a college campus, was selected as a tribute to the new George Mason College which opens its doors in the City this fall. It treats a serious matter, that of academic freedom in the classroom, with the light, fast, comical touch of Thurber. The hero, Professor Turner, is misunderstood by almost everyone, including his wife, the college newspaper, and the football hero of yesteryear returning for a home coming home.

While "The Male Animal" is a change of pace from the more serious "An Enemy of the People" which the group presented last Spring, it still brings to life problems which face any man who feels that he must defend his beliefs, even if it means the loss of his job. The dialogue sparkles with Thurber wit as the hero stumbles from one scene to the next.

Since the Community Theatre had such an overwhelming response to its last arena type production, the play will be staged in the round at the Fairfax City Hall. Arnim Seielstad, who appeared as the scheming editor Hovstad in "An Enemy of the People" will direct the play. Mr. Seielstad recently directed a play which reached the finals in the Northern Virginia Play Tournament. He also appeared in "Come Blow Your Horn" earlier in the year.

The younger group meets from 9:00 to 10:30 a.m. and older group from 10:30 to noon. The fee for the classes is \$12 per semester.

...Creative Dramatics is the expression of thoughts and feelings in the child's own words and actions. At all age levels the magic of enacting a story, poem, play or life-situation is ever-beckoning. Story telling is a part of the learning process. A natural evolution of the story is the dramatization. This is the spirit of Creative Dramatics.

...The first semester covers work in pantomime and dialogue scenes. Poems and life-situations are used as the springboards in these early classes. The second semester will stress characterization and story dramatization. Each semester will be concluded with a recital which will be open to the public.
