OUTDOOR CHRISTMAS DECORATIONS: C O N T E S T ! Each year the City of Fairfax has sponsored this contest on a City wide basis. This year however, the City Council has decided to spend the awards money, approximately \$200.00, towards decorating prominent publicly-owned locations. This program had been started when the total population was about 2500 people. There are now about 16,500 people in houses and apartments, and this program seemed to be in need of great expansion or, on the other hand to be dropped. At our Board meeting we voted on a motion to continue this contest in CCH. There will be cash prizes of \$25.00, \$15.00, and \$10.00; 1, 2, 3, respectively. Some of you very efficient people are already decorated! However, in order to give some of the rest of us time, judging will be on the evening of December 23rd. Happy Decorating!

PETTY VANDALISM: and the juvenile problem in CCH has been a topic of discussion at the 2 meetings already held by the new Board. Some members of the Board were completely taken aback by these reports while others added other incidents. A motion was unanimously carried to publicize this information. We will at this time deal with the most current problems which can be expected. Since we at one hand are sponsoring an outdoor decorating contest and since last Christmas quite a number of outdoor lights were stolen, details on other past incidents can be gotten by calling your Area Representative. Last Christmas a number of home owners reported to the Police. A conversation with Major Young brought out the fact that not enough of these cases were reported to them and that he hoped everyone who felt their decorations (or anything, for that matter) had been tampered with would call immediately! He says that all of these reports begin to form a pattern when enough are made. That this sort of thing exists all over the City, County, etc. That only in the communities where the citizens have banded together and reported everything have these incidents been cleared up.....and in a matter of a few weeks! You will really be serving the culprit, the community and yourself if you feel comfortable about reporting these incidents. Major Young has already accepted our invitation to come to our next Board meeting which will be held on Monday night, January 6th. One of the detectives from the Juvenile Division will accompany him. We will discuss this problem in general and as it applies to CCH specifically. If you have any thoughts on this subject, or any other, please call your Area Representative.

CITY SIDE: The VFW's request for a special use permit of 540 Old Lee Highway was turned down by the Board of Zoning Appeals as not the proper utilization of this land since it is in a restricted residential neighborhood.

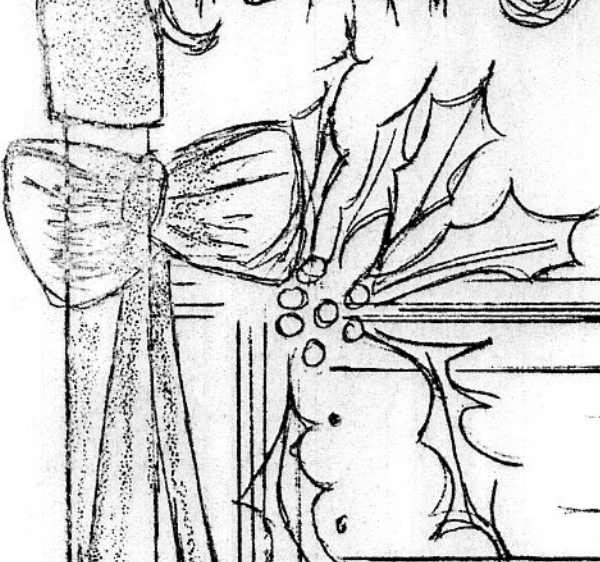

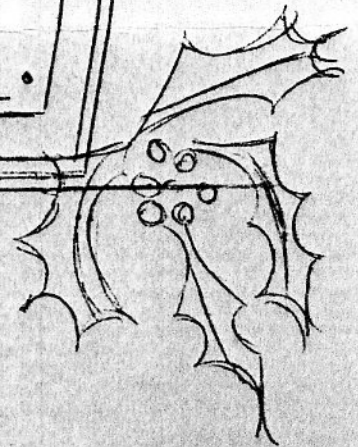
