Memo to: Fairfax City Planning Commission

Subject: Special Meeting - Monday, December 28, 1964

December 21, 1964

On January 5, 1965 the City Council will consider the location of the new National Guard Armory within the City. I think it incumbent upon the Planning Commission to provide the City Council with its best advice and recommendation on this most important governmental use within the City.

Accordingly, I am calling a special meeting of the Planning Commission on Monday, December 28, 1964 at 8:00 p.m. in the Council Chambers at City Hall for the purpose of discussing various locations within the City appropriate for the construction of the Armory and determination of our recommendations to the City Council.

I am sure each of you has his own views with regard to an appropriate location for the Armory and I would hope that we could discuss every appropriate location in detail; however, the following sites have been considered off and on during the last two years and are worthy of our special attention:

- Site 1 - On Rt. 236 immediately south of the oil storage facility.
- Site 2 - Between the John C. Wood Elementary School and the St. Leo's Catholic Church.
- Site 3 - Immediately north of E. School Street between Rt. 123 and University Drive.
- Site 4 - Rt. 50, near Jermantown Road and southwest of Sidnew Lanier School.
- Site 5 - The Eaton tract, north of the State Highway facility and east of Rt. 123.

This will not be an advertised public hearing within the meaning of the Zoning Ordinance; however, it will be open to the public and I earnestly hope that all persons in attendance will give us the benefit of their views. The Secretary is mailing a copy of this memorandum to each civic association and business association within the City so that they may be apprised of this meeting and make an appropriate representation.
