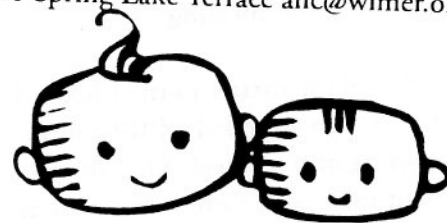

In May 2002, several Country Club Hills residents suggested at a CCHCA meeting to turn the vacant city-owned lot at the intersection of Spring Lake Terrace and Brookwood Drive into a park.

Several more community meetings and board meetings were held to discuss various ideas. At the end of these meetings, our neighborhood agreed to several great ideas:

- removing the yard waste piled up over 50 years
- clearing out overgrown brush to expand the width of the park
- placing split rail fences at each end of the park
- planting eight new large trees
- planting dozens of smaller trees and bushes
- planting scores of new flowers
- erecting a pavilion at the west end of the park

Over the next three years, every member of our City Council visited our park, and some volunteered to get muddy and sweaty cleaning up and planting. The City also provides several community appearance grants that were used by CCHCA to buy trees, bushes, and other plants. Then in September 2005, a Country Club Hills Civic Association representative spoke before the Fairfax City Council and requested that our new park be named "The Commons," as a result of a vote held at a Civic Association meeting.

The City Council referred the matter to the PRAB. A CCHCA representative then attended a PRAB meeting to discuss the naming of the parcel. After discussion with PRAB about their park naming policy that requires a geographic location description, the PRAB agreed to "Country Club Hills Commons," and on October 25, the City Council voted unanimously to name our new park "Country Club Hills Commons." On November 1, 2005, the Council is scheduled to adopt a more formal City resolution officially naming the park.

Thanks go out to everyone who participated in our many community events --from pulling weeds and planting trees to gathering for our annual picnics--to transform the empty lot into a place where people can gather to play, socialize, and be part of the wonderful place we call home-- Country Club Hills.

P.S. We'll still call it "The Commons" in our CCH newsletter.

Old Lee Highway Improvement Project

CCHCA has received copies of a report submitted to the Mayor and City Council concerning recommendations to improve Old Lee Highway. The CCHCA Board has directed a group of members to review the report and collect comments and concerns from all members. We are working with representative from Old Lee Hills and Great Oak so that the communities can present a consensus to the City Council. Emergency Preparedness

Fairfax City government prepares for everyday emergencies. However, during a disaster, the number and scope of incidents can overwhelm conventional emergency services. CCHCA is making preparations to ensure that we can take care of ourselves and our neighbors in a disaster. One way CCHCA is looking at making these preparations is, in conjunction with local authorities, to form our own Community Emergency Response Team. The Community Emergency Response Team (CERT) program is an all-risk, all-hazard training. This valuable program is designed to help you protect yourself, your family, your neighbors and your neighborhood in an emergency situation.

In the CERT training, citizens learn to:

- manage utilities and put out small fires,
- treat the three medical killers by opening airways, controlling bleeding, and treating for shock,
- provide basic medical aid,
- search for and rescue victims safely,
- organize themselves and spontaneous volunteers to be effective,
- and collect disaster intelligence to support first responder efforts.

Successful Planting Party at New Park: Commons Area

On Saturday, October 15, 2005, Country Club Hills enjoyed a beautiful day and record community turnout as we planted more than forty trees and shrubs to improve our new community park, "Country Club Hills Commons."

Four years ago, the empty lot at Spring Lake Terrace and Brookwood Drive contained large amounts of yard waste and was nearly completely overgrown with weeds. After hundreds of hours of "sweat equity" among residents to clear and then landscape the area starting in 2002, the vacant parcel transformed into a wonderful and beautiful park, complete with new shrubs, new trees, new flowers, a 20' by 20' pavilion, a trash can, and split rail fences at each end.

Community Candle Light Vigil to Honor Iraq War Dead

On October 26, 2005, twenty-five residents gathered quietly and honored U.S. service members who died in the Iraq War. A day earlier, the number of U.S. fatalities reached 2,000. Citizens holding candles gathered in the early evening to pay respects to those killed as well as those U.S. service members injured in the war—now reported at more than 15,000. The solemn event included a moment of silence to remember those fallen, including an estimated 30,000 Iraqi civilians, followed by nearly an hour of open public discussion about the causes and consequences of the Iraq War.

On the Neighborhood Planting

All of the volunteers who showed up deserve a huge pat on the back for their sweat! I hope that you'll all feel good as you watch it grow into a beautiful area of your very own.

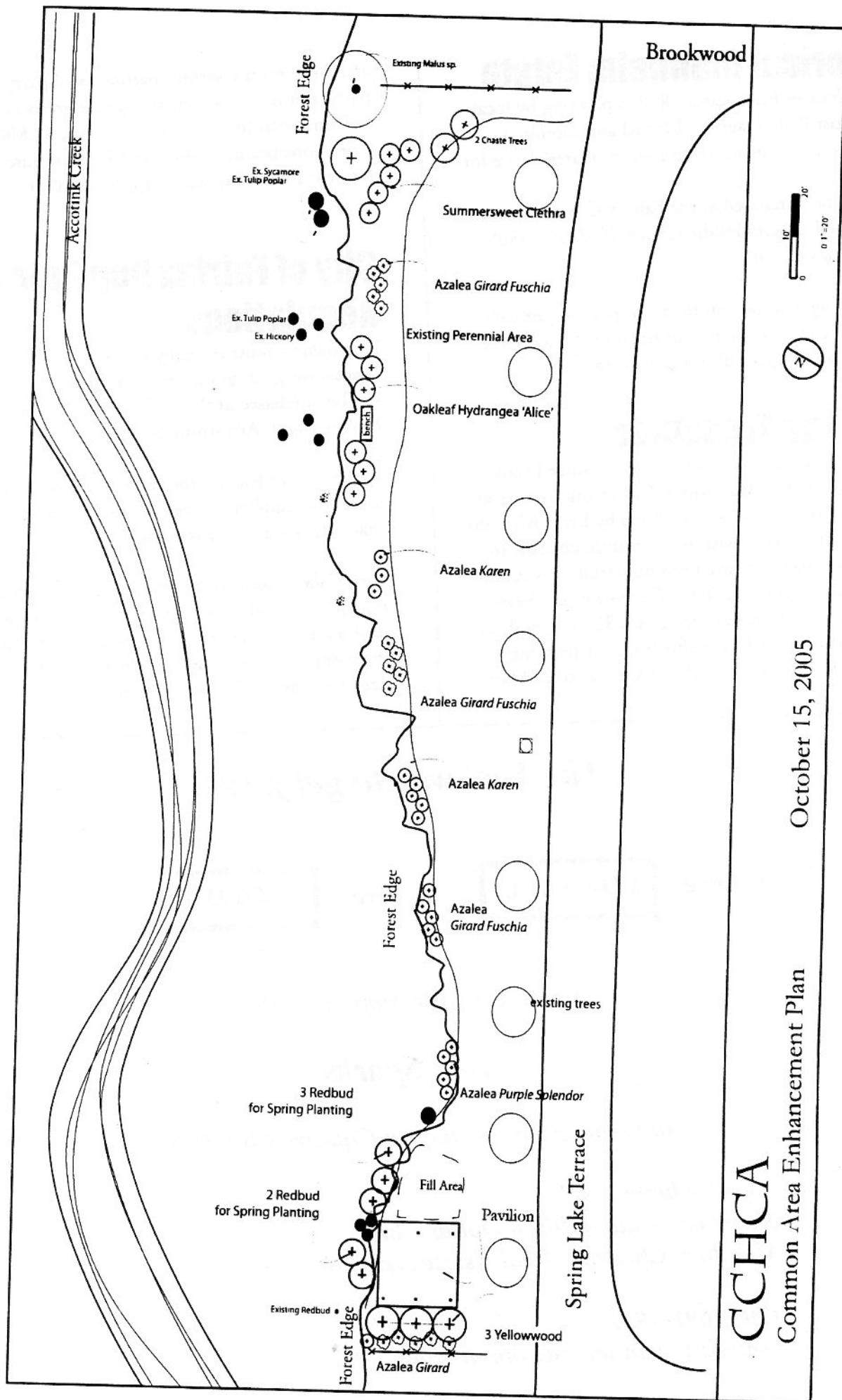
I chose plants that I thought would carry the beauty of the woods into the open and unify the neighborhood with some of the common yard favorites. Those who live along the woods watch deer, squirrels, birds, and a fox or two move about the woods. The woods themselves are the perfect embodiment of the indigenous plant community for this area: beeches, oaks, hickories, native azalea, sassafras, shrub honeysuckle, spicebush, and gorgeous spring ephemerals like may apples, trout lilies, bloodroot, and jack in the pulpit.

The three trees next to the pavilion are yellowwoods, chosen for their woodsy character, fragrant blooms and silver bark that's similar to the beeches in the woods. It's a hardy native that will grow into a medium sized tree. A planting in this neighborhood wouldn't be complete without those strutting spring bloomers, azaleas. I used three types of azaleas that are planted in unified groups along the edge of the woods. The three types are Girard Fuschia, Karen, and Purple Splendor all in the pink to purple range, chosen for their different characteristics. All are cold hardy and evergreen. The Karen azalea will bloom first in the spring, so watch for it.

There are 6 large oak leaf hydrangeas. I chose these for their large textured leaf, summer bloom and the deal that the nursery gave us on them! Farther along in that same area behind the azaleas that we planted in front are some large (and a little leggy) summer sweet clethra that will be absolutely amazingly fragrant when they bloom next summer. They look scraggly now, but you'll come to love them. The two shrubs at the Brookwood end of the commons area that are in front of the mulched bed are chaste trees or vitex. Those will bloom profusely in the summer and will attract all sorts of butterflies. Let's hope that the neighborhood dogs go easy on those plants over the winter!

From the Treasurer

A quick rundown of our bank balances since I took over as Treasurer in May with CCH's bank balance at about \$5,000. Thanks to the efforts by Ernie Klimonda and Hildie Carney with membership, deposits to CCH's bank account have been numerous this summer and fall, totaling \$2,050. There have also been deposits of \$1,000 from a city grant, \$275 from directory advertising and \$65 profits from the painting of street numbers on the curbs. Expenses since May

are: \$620 for the various parties (pool party, block party, smore sing along, and ice cream social), \$55 for welcome gifts for our new neighbors, \$1,800 on the Commons beautification, and \$300 in misc. The end result is a bank balance of approx \$5,600.

City of Fairfax Dog Rules & Regulations

Dog owners must annually purchase Fairfax City dog licenses for all dogs four months of age or older. They can be purchased at the Office of the Treasurer in City Hall at 10455 Armstrong Street.

In the City of Fairfax, the size of a property determines the number of dogs age four months and older that may live at a city residence.

City Code permits one or two dogs to be licensed at a residence regardless of lot size. However, owners must have a lot size of at least 7,500 square feet to house three dogs. For four dogs, residents must have a lot size of at least 12,500 square feet.

No more than four dogs are permitted to live at any residence. However, dog owners with more than the permitted number of dogs who have been continually licensed in the city since October 1999 may be exempted from this city ordinance. For information, call 703-385-7820.

All dogs in the city age four months and older are required to be licensed and have valid rabies shots. For information, call 703-385-7900.

Owners must keep dogs on a leash when they are not on their own private property, and must obey pooper-scooper laws. For information on animal laws, call 703-385-7924.

Owners must register dogs found by a court to be dangerous and euthanize dogs found by a court to be vicious. Dog owners must pick up waste deposited by their pets on others' property or on common ground. Our CC&Rs state specifically that no animals may be raised, bred, or kept for commercial purposes.

Owners must have all dogs and cats four months or older vaccinated against rabies. Impounded animals are kept at (contact city police first!):
