#### **MESSAGE FROM THE PRESIDENT**

What makes us a society will forever be debated, but what makes our neighborhood a community is a simple formula. Membership dues together with volunteer labor and donations combine to promote the general welfare of our neighborhood as a whole and as social individuals.

No one can make you pay dues or be an active member of this community and we are grateful to the members who have already stepped forward to pay their dues and volunteer their time and effort. But as of now only 140 out of 325 households have paid their dues and joined this year. I am asking that the other 185 make the same commitment your neighbors have. Even if you do not attend activities or choose to volunteer your time, paying a small, annual dues fee will still help provide great advantages for the community.

It seems fitting that the CCH Membership season coincides with the holidays. During this time of thankfulness and generosity we ask that you think of those who surround you on a daily basis, by becoming an even closer part of the CCH family. It takes only a few minutes and ten dollars to know that concerned volunteers will be there for you or for you and your family, providing a social network geared to make improvements that can affect property values and enhance lifestyles. Financially and socially it makes sense to help your friends and neighbors maintain this unwritten cooperative community contract.

Our Country Club Hills entry signs need replacement. They have long served as an invitation to families considering relocating in this area, but are now in major disrepair. At this time we do not have all the necessary funds for replacement (at several hundred dollars apiece). The signs are a reflection of who we are and of our self-respect as a community; so I am asking on behalf of the entire neighborhood that everyone consider donating money towards replacement.

The Eccho newsletter has been reconstructed and is now available as a running newsletter site accessed through the CCHCA website. Along with the changes to our electronic version, the hard copy version is also undergoing its own transformation to reflect a "greener" attitude.

The Country Club Hills Board of Directors will plan another ambitious upcoming slate of social activities for 2012. Currently we have an acting VP Social Events, but we are seeking lead volunteers to partner in the organization and running of individual events. Events are scheduled during the Winter Meeting in February.


