The January meeting will not be held on the regularly scheduled date, but later in the month on a date to be announced. Vice-President Harvey Miller, Program Chairman, promises an interesting program.

MALL PLAN FOR DOWNTOWN AREA

As we go to press announcement has been made of prospective action by the City Council on the proposed Mall Plan. A meeting will be held on Tuesday, December 21 at the City Hall. The Executive Committee, as representatives of the Association, advised the City Council in November, they favored a study of the feasibility of the plan, a traffic survey, etc. as were nearly all groups and citizens who appeared. Some concern was expressed over taking action that would prejudice funds allocated by the State for the widening of Route 236.

The proposed plan would provide a by-pass of the Downtown area with the west-bound traffic being routed across a part of the parking lot of the University Shopping area and along North Street past the Post Office, to rejoin the present route, a short distance west of the Courthouse, in the vicinity of the Courthouse parking lot.

The traffic east-bound would be routed around the Courthouse to the South and rejoin the present route near the University Shopping Center. The plan envisions the present street to be closed to

vehicles with a Mall in the center. The old Erps Ordinary, the Ford Building and other historic sites would be adequately marked. It is anticipated the other buildings in the area would be modernized or rebuilt, office buildings, shops, etc., established along the historical architectural lines comparable with the Courthouse and Bank buildings.

It is our information that the State Highway officials, while not opposed to the plan possibly feel that it is too late to make this change in the routing of 236.
